# **EXHIBITOR INFORMATION**



All exhibitors are advised to read the below information before attending NSA North Sheep 2025.

#### **Bio-security**

Please be aware of any bio-security advice either shown by signs or given verbally by event stewards.

**Maedi Visna Accredited** – if you have MVA sheep please ensure you unload in the correct place (signs will be displayed). <u>You must</u> hand in a SAC form with your AML1 form BEFORE unloading.

#### **Build up**

The site is easily accessible from the A66. Follow the yellow AA traffic management signs.

Access to the site for <u>articulated</u> vehicles can only be guaranteed on MONDAY 2nd JUNE from 11am to 4pm.

Build Up Access for stands will be: Monday 2nd June 10am to 5pm Tuesday 3rd June 10am to 6pm The site will be closed after these times with security guards on patrol. Please obey instructions given by the stewards with regard to routes and parking.

We advise all lorry drivers to keep to the avenues within the outdoor trade stand area and to avoid driving over space allotted to other exhibitors. We advise all exhibitors with show units to arrive early to gain easy access to their site.

A loader will be available at the following times to assist with unloading and loading: Monday 2nd June 10am to 4pm Tuesday 3rd June 10am to 5pm Wednesday 4th June 5pm to 7pm Thursday 5th June 10am to 12noon The loader is a hired vehicle, and the driver is only contracted to drive at the above stated times.

All vehicles must be removed to the trade/exhibitor/sheep car park after unloading to avoid congestion.

A maximum of two vehicle passes will be sent to trade/sheep exhibitors, this is due to space restrictions within the trade/sheep exhibitor car park, exhibitor vehicles without a vehicle pass will have to park in the free public car park. Please note access to the trade/exhibitor car parks will only be possible from 7am to 8am on Wednesday 4th June. No exhibitor or vehicle passes are required on the build-up days.

No exhibitor shall be permitted to arrange their stand or to place signs/equipment in such a manner as to obstruct the light or to inconvenience or disadvantage the display of any other exhibitors.

Every effort is made by the organisers to ensure all stand pitches are the best they can be. It is recommended you allow flexibility in your stand designs. Please remember this is a working farm and not a standard exhibition facility.

Staff Entry – it is your responsibility to ensure all staff/colleagues have sufficient admission tickets before the event. Personnel arriving at the gate with no ticket will be charged full price to be allowed entry to the event.

#### **Stand Competitions**

Best Indoor and Outdoor Trade Stand, Best Sheep Breed Society Stand and Best Sheep Breeder Stand will be judged on 4<sup>th</sup> June from 8.30am, please ensure your stand is prepared for the judging.

#### Wool on the Hoof Competition

The best wool on the hoof competition will be judged from 8.30am on the 4<sup>th</sup> June. Please notify entries by 26<sup>th</sup> May to Chris@nationalsheep.org.uk.

# Breakdown

No article on exhibition may be removed and no stand dismantled at the event before 5pm. Exhibitors vehicles will be allowed onto the site after 5.30pm (subject to Health & Safety) on Wednesday 4th June, please follow the instruction of the stewards at the event. All exhibitors shall be responsible for the removal of refuse from their stand. Outdoor stands shall completely restore the ground (grass field) to how they found it. A skip will be on site for refuse.

## Security

There will be a security presence onsite from 7pm to 7am both Monday 2<sup>nd</sup> June and Tuesday 3<sup>rd</sup> June. Exhibitors should take all reasonable care to secure their stand. NSA is not responsible for any damage or theft from any stands at NSA North Sheep 2025. All exhibitors and visitors are reminded that if they see anything suspicious e.g. activities or parcels, please notify event officials immediately.

# **Visitor Opening Hours**

The event is open to the public from 9am to 5pm on Wednesday 4th June. Stands should be manned at all times.

# Catering

Hot food and drinks will be available from the hours of 12pm to 6pm on Tuesday 3<sup>rd</sup> June and from 7.30am to 5pm on Wednesday 4<sup>th</sup> June. The sole catering and bar rights have been granted.

# **Electricity and Water**

Exhibitors who have indicated that they require electricity on their stand booking will be supplied with a single 13amp socket, double 13-amp socket or ceeform socket. The electrician will be on hand during build up and event day. Generators will be used for the electrical supply; please note electrical supply may not be available until 8am on Wednesday 4<sup>th</sup> June. Adding electric sockets to your booking from now on can only be done if services allow (i.e. time and supplies) and at a cost of £200+vat per socket.

Water will be available from within the trade stand area. Take note of signs indicating 'drinking water' and 'non-drinking water.'

- (iii) A suitable fire notice should be displayed upon your stand giving the action to be taken in the event of a fire.
- (iv) The organisers require a copy of a fire-retardant certificate for all marquees and tents at the event. Can you please send or fax a copy of this to the organisers before the 30<sup>th</sup> May.

Exhibitors are reminded that they are responsible for the observance, by themselves, their employees and their contractors of the Health and Safety at Work Act 1974 and the relevant statutory provisions that covers all safety regulations. All exhibitors indemnify the association from any claims made in connection with the exhibitor's staff, equipment, display, animals or vehicles.

**Veterinary Treatment** – if veterinary treatment is required for any animals, all charges incurred must be paid by the breed society/company or breeder concerned. NSA reserves the right to call a vet in the absence of the society/breeder/stand official responsible.

NSA <u>does not</u> provide straw, hay or feed for stands. Please ensure those supplying sheep are aware of this.

Please ensure that you complete an AML1 for your journey to the event along with another AML1 ready for your return journey. Ensure both forms are handed in to the stewards on your arrival.

Only those stands who booked hurdles on their booking will have been allocated them.

Sheep must arrive between 9am and 6pm on Tuesday 3<sup>rd</sup> June – please ensure those supplying sheep are aware of these times. As a condition of the Animal Gathering License a veterinary inspection will take place after 6pm.

All sheep on stands must have been treated with a scab treatment.
